PRACTICUM AND CULMINATING EXPERIENCES

Clinical Training

Students admitted into the CMHC program, upon completing their first year of coursework, are required to perform practicum hours in a clinical setting across three semesters of at least 450 hours (280 hours must be face-to-face counseling). Practicum hours must be completed concurrently with the sequence of academic practicum courses. Students who are unable, for any reason, to complete the required practicum hours during the CMHC 699A, CMHC 699B, and CMHC 699C courses will need to enroll in additional practicum courses (CMHC 699D) until their required hours are complete.

Comprehensive Exam

Students must pass the Counselor Preparation Comprehensive Exam (CPCE) in order to complete program requirements. See Handbook for more information.

BBS Licensing

Upon completion of all program requirements, students may submit an application to be certified for licensure by the California Board of Behavioral Sciences (BBS).



Commencement Ceremony Participation
